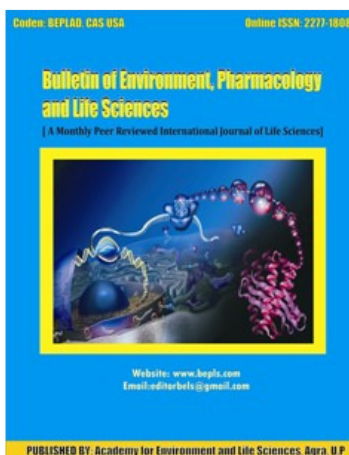

Categories of paper

Short Communications: A Short Communication is suitable for recording the results of complete small investigations or giving details of new models or hypotheses, gene isolation and identification, innovative methods, techniques or apparatus.

Review: Submissions of reviews and perspectives covering topics of current interest are welcome and encouraged. Mini-reviews are also peer-reviewed.

WITHDRAWAL OF MANUSCRIPTS

If the author requests withdrawal of manuscript after submission within the time span [Under 48 Hours] when the manuscript is still in the peer-reviewing process with Editors/Referees, author is allowed to withdraw the manuscript without paying any withdrawal penalty whatsoever. However, it is unethical to withdraw a submitted manuscript from one journal if accepted by another journal. After the manuscript is accepted for publication either through journal editors or guest editors or conference organizers, the withdrawal is not permitted by Academy for Environment and Life Sciences (AELS). If the authors or conference organizers or a third party withdraw manuscripts any time after final manuscripts have already been submitted to Academy for Environment and Life Sciences (AELS) for processing, the request is not entertained without a significant withdrawal penalty. Authors or conference organizers or a third party are not allowed to withdraw submitted manuscripts because the withdrawal wastes valuable manuscript processing time, money and works invested by the publisher. The authors or conference organizers or a third party must always pay \$200 per paper manuscript processing charges as withdrawal penalty to the publisher even if the withdrawal is permitted. The withdrawal of the conference papers by conference organizers will never be permitted and the conference organizers will be punished for withdrawal by paying a withdrawal penalty of US\$500 per manuscript. Withdrawal of manuscripts is only allowed after withdrawal penalty has been fully paid to the Academy for Environment and Life Sciences (AELS) by the authors or conference organizers or a third party. Any reason whatsoever of withdrawal of submitted manuscripts is treated as invalid and completely unacceptable under any circumstances. Publisher is not responsible for any damages whatsoever resulting from this consequence of the author's or conference organizer's or a third party decision.

PUBLICATION RULES AND REGULATIONS:

1. Publication Time: 1 to 2 Months [Depend on Review and No. of papers]
2. If manuscript published online, Editorial Board will be not permitted to authors and co-authors for any corrections in the manuscript.
3. Authors should fully disclose all funding sources of the research and relevant conflicts of interest.
